



Canada 150 Research Chair Glendon College, York University

Glendon College, York University, invites applications from individuals interested in nomination for a Canada 150 Research Chair in Migration, Citizenship, and Diversity, to commence July 1, 2018. Glendon is home to a rich diversity of researchers working in fields across all three Tri-Council granting agencies (Health, Social Sciences and humanities, Natural Sciences) and in multiple languages.

The position is a tenure-stream appointment at the rank of Associate or Full Professor conditional on the successful nomination of the applicant as a Canada 150 Research Chair. To be eligible for this award, nominees must be internationally based at the time of the application (both working and residing outside of Canada), including Canadian expatriates. Applicants must be able to work in English and French.

Specific research areas of interest for nominees include *Comparative World Politics, Ethnic and Racial Studies, Governance, Digital Citizenship and Surveillance Society*. Outstanding candidates in other areas of *Comparative Free Speech Jurisprudence, Media-Citizen Relations, Analytics and Visualization* are also encouraged to apply

The individual sought will be nominated for a Canada 150 Research Chair at the \$350,000 per year level. Appointments to Canada 150 Chairs are for seven years. Further information about the Canada 150 Research Chair program is available at <http://www.canada150.chairs-chaires.gc.ca>.

The successful candidate will have a record of excellence in scholarly research including publications appropriate to their stage of career, and will demonstrate a commitment to service, and to excellence in teaching at all levels. The successful candidate will be prepared to participate actively in one or more Glendon departments, including teaching at a reduced load, and be suitable for prompt appointment to the Faculty of Graduate Studies in relevant programs and the Glendon School of Public & International Affairs.

For this nomination, York is particularly interested in candidates with diverse backgrounds and especially encourages candidates in equity, diversity and inclusion categories. York acknowledges the potential impact that [career interruptions](#) can have on a candidate's record of research achievement and encourages applicants to explain in their application the impact that career interruptions may have had on their record of research achievement. York University is an Affirmative Action (AA) employer and strongly values diversity, including gender and sexual diversity, within its community. - quality of the recruitment and outreach strategy in terms of demonstrated commitment to equity, diversity and inclusion; and
- quality and extent of the institution's commitment to ensuring that the opportunities of the chairholder's research program will be made available to individuals from the four designated groups.
